

# Privacy Policy

The goal of the Wisconsin Distributed Resources Collaborative is to assist the creation of a sustainable market for the deployment of small-scale generation and energy storage technologies in Wisconsin.

## Privacy Statement for Wisconsin Distributed Resources Collaborative

This Privacy Policy describes if and how your information is collected, used, and shared when you visit wisconsindr.org (the "Site").

### Information We Collect

When you visit the "Site", we automatically use standard "Log Files" to collect certain information about your device, time zone, and type of organization if available (e.g., .org, .com, .gov). Additionally, as you browse the "Site", we collect information about the individual web pages or information viewed, what websites or search terms referred you to the "Site", browser type, and information about how you interact with the Site (e.g., reviewing presentations, reports, etc.). We refer to this automatically-collected information as "Device Information".

- ➡ Information to fund our site by showing advertisements as you browse our site. Our "Site" is funded entirely by membership contributions.
